### **President's Letter**

#### **Gentlemen and Ladies**

Hi all 12 F R (V) A members and welcome to the Spring edition of the newsletter, albeit a little late, due to numerous tasks undertaken in the past few months, some of which I have outlined below.

#### Visit to Darwin

The major issue I would like to bring to your attention is the meeting myself and John Allen attended in Darwin with the CO (Lt. Col. Neil Sweeney), Adjutant (Capt Duncan Anderson) and the RSM (WO1 Dave Rayment), of 8/12 Medium Regiment on 2 September.

The reason for this meeting was to offer 8/12 membership of our Association, as the current holder of the "Coral Honour Title" and as the current Regiment, which partly evolved from 12 Field Regiment.

The outcome of the meeting is reported on Page 3 of the newsletter. In brief, it was a very positive meeting and I feel confident that we will move ahead in terms of the number of members, which should provide increased confidence in the longevity of the Association.

One of the main considerations for the involvement of 8/12 Medium Regiment will be the name of the organisation, which we have discussed repeatedly at previous AGMs.

I would ask you to consider carefully the implications of our remaining known as a "Vietnam" Association. Once we are all gone, there will effectively no longer be an association which would be a travesty if it had such a limited life span.

The proposal to re-name the

Association should be considered along the lines of the proposed move within the Army to dispose of terms such as Field or Medium, effectively meaning that 8/12 Medium Regiment, might become 8th/12th Regiment RAA, and 1 Field Regiment might become 1st Regiment RAA.

### **Gunner Ian Scott remembered**



The Minister for Veterans' Affairs, Alan Griffin, presented Marlene Smith, formerly the bride of 6 months of Ian Scott, with a framed photo of Ian with all medals and ACB to which he was entitled at a well-attended function in Brisbane on 14 September.

Members will remember that Ian and Chris Sawtell, both National Servicemen, had been in Vietnam six and seven days respectively when they were killed in the first attack on the morning of 13 May, 1968 at FSB CORAL in Bien Hoa Province.

Marlene had never received Ian's medals and this oversight was exacerbated by our not inviting Marlene to the Coral Honour Title presentation in Canberra in May 2008.

The function was attended by a large number of Diggers from Artillery, Infantry, the Div Loc Battery and others (see photo), including

The Minister was supported by the Deputy Commissioner for DVA, Queensland, Allison Stanly.

Marlene was supported by husband, Graham, and their lovely daughter, Tonina. Scott Smith was unable to attend due to commitments in Melbourne. Our love and undying respect goes to Marlene and her wonderful husband, Graham Smith who was without doubt the Man of the Match.

### Visit to 8-12 Medium Regiment, Darwin

President John Sullivan and Secretary, John Allen, travelled to Darwin to speak with Lt Col Neil Sweeney, Captain Duncan Anderson and RSM David Rayment regarding the feasibility of establishing a relationship with 8/12 within the 12 Field Regiment (Vietnam) Association. An informal draft agenda was forwarded to the Commanding Officer prior to arrival. The responses to those items appear hereunder.

### 1 Possibility of including 8/12 Regiment members in our Association

Lt Col Sweeney (hereafter "the CO") supported the proposition of offering membership to current and past members of 8/12 Medium Regiment. He was of the view that exmembers were more likely to take up membership.

### 2 Renaming our Association.....

The CO was not concerned about the name of the Association. When asked, he said that, in due course, it was likely the term "Medium" would be removed from all medium artillery regiments in Australia. There was general support for the Association to be called 8-12 Regiment Association RAA or variations thereof.

The CO advised that, to his knowledge, there was no existing 8/12 Medium Regiment Association, and that he had not been approached by anyone intending to establish such an organisation.

Following comments made by the CO that their workload would be very intense next year, there was no discussion on launching the new association at Robertson Barracks. The CO was clearly receptive to receiving or-

ganised visits from members of the current association, particularly on major events such as ANZAC Day, Australia Day, Vietnam Veterans Day etc, and reunions such as the 104 Battery Reunion in Darwin next year. The Annual Regimental Ball was also mentioned.

### 3 Discuss incentive schemes.....

8/12 Medium Regiment has an established award scheme for current members and was receptive to the Association sponsoring an award. The nature of the award (plague and other rewards) would be He cautioned agreed. that not all members are "gunners". Non-gunner staff are now supplied by RAAOC, RACT, RASIGS etc according to the specific job requirement. He said that 33% of members did NOT wear a gunners hat badge. He also commented on the number of members female (currently 8%).

### 4 Association Welfare Officer.....

While the CO understood the raison d'etre of this item, he said that the Army looked after members who returned from active service. He recognised our great strength in our civilian experience and was very keen to see the Association consider a role in re-integrating retiring members into civilian life. This role might include local support by way of introduction to the community, prospective employers and by having an ex-military contact to discuss issues from time to time.

# 5 8/12 Regt Representation on Committee

There was no discussion on the issue of State Representatives for the Association.

### 6 Cost of Membership

There was no discussion on membership fees.

#### 7 Coral Honour Title

The CO assured the President that the Regiment took great care of the Honour Title which was in a large glass case with other memorabilia in a constantly air-conditioned building. He advised that there was consideration being given to have a suitable case constructed to further protect the charter, but this was estimated at \$10,000 and was beyond the Regiment's resources at this time.

He did comment that the Honour Title might go to the School of Artillery in the future or 102 Battery if it were raised again.

### 9 RSL Trust for wounded soldiers.....

The CO responded by saying that it was not appropriate for him to suggest where the Association should put its funds. He expressed an opinion that the Association should consider its own members and their families first.

### 10 Access to soldiers' email addresses......

The CO was very supportive of the Association contacting the members of the Regiment, particularly those mobilised for duty overseas. He said that the members valued recognition of their service by way of stories and photos of them in newsletters. He said that we should be sending e- and hard copy newsletters from the Asso

ciation to as many units as possible (not limited to Artillery Regiments). He referred to the latest copy of the Liaison Newsletter and encouraged us to make sure we were listed or featured in this document.

#### 11 CORAL DVD.....

The CO asked for two copies of the CORAL DVD. He said he saw the DVD as a training aid, particularly for NCOs. He was given three A3 copies of the DVD jacket and was asked it these could be posted throughout the Regiment to promote individual sales.

The CO and RSM took the President and Secretary on a tour of the site. The CO emphasised his willingness to host visits by the Association to the Regiment; 104 Bty representatives will be informed of this immediately.

There is clearly a willingness to build a relationship between the Regiment and the Association, with particular emphasis on supporting retiring members to integrate into civilian life.

It is also clear that the Regiment per se does not seek any representational role within the Association nor does it see any significant influx of currently-serving members of 8/12.

### Vale Neil McDonald 1940-2009

This is a precis of two emails we received from an ex-gunner who had not shared his SVN experiences with his family until two months prior to his death in October, 2009, and, later, his son. Neil had written to resign his membership as he tidied up his personal affairs.

In more ways than one, he is not alone.

### Dated 21 August, 2009

Thank you John , for keeping my name on the Associations Membership list . \$ 10 these days DO NOT buy you very much these days and I am quite happy to pay that to have a CONNECTION with the Association even though I do not know many members. I am happy to receive e - mails at anytime John because it helps to break up the day with a bit of interest . Thank You .

However, come the Final, I will have to leave that duty to one of my off-spring rather than for my wife to advise you, John.

Now for a bit of history , I joined the Army at the rebellious age of 18 years in 1958 . After Corp Training at the School of Artillery , I was posted to 111 LAA BTY R.A.A. with 40 mm" BOFOR " Anti - Aircraft Guns . (That makes me a BIRD GUNNER and not a DROP-SHORT). Sorry!!

With 4 FD REGT R.A.A. being posted to NUIDAT in June 1967 without a Sgt Tech Storeman, I arrived "in country" on 1st July 1967. I was attached to the "Q" Compound which was at "Martin's Corner" under Capt John Martin as Q.M. and WO 2 Bill Dick as R.Q.MS.

Most of my time at NUI DAT was spent on OPERATIONS doing RE-

SUPPLY from our Forward Areas back and forth to NUI DAT. I would have been at Bien Hoa Air Base on about 8/9 th May 1968 when I was relieved by W O 2 Alan Johns (R.Q.M.S. for 12 FD REGT R.A.A.) I think.

A couple of days later, we were sitting at the end of LUSCOMBE AIR STRIP to go home. I think that would have been the start of the Battle of Coral. Discharge came 9 months later after nearly 11 years in Army Service to my country and I think that is enough.

As for joining 12 FD REGT (Vietnam) Assoc and joining in on the Battle of Coral Celebrations in Canberra last May, it was an absolute Pleasure in connecting after 40 plus years.
